

Update budget load to correctly calculate annual rate for less than 1.0 FTE	Navigation: Menu > BOR Customizations > Budget Prep > Budget Prep Load
	Issue: The FTE is not included in the calculation for hourly employees which results in the annual rate being overstated for part-time employees
	Root: This is a bug that has caused the system to not work properly.
	Solution: The process used to load new budget job data will be updated to take into consideration hourly, less than 1.0 FTE when calculating an annual rate.



MSS Summer Pay Security for Centralized	Navigation: Menu > BOR Customizations > BOR
Security Model	Virtual Table
	Prior to the Release: MSS Summer Pay was hard coded for the Decentralized (R1) Security Model.



After the Release: The MSS Summer Pay logic was modified to include the Centralized Security Model. The BOR Virtual Table (security) was updated to include required fields for MSS Summer Pay for all institutions, Decentralized or Centralized.

These messages are not hard stops, but information only messages. After the Release: Logic in the report will only
	return messages for the current pay end date, reducing the number of messages and targeting only the current Pay Run ID.

Summer Pay Page	Navigation: Payroll for North America > Payroll Customization > AYP/Summer Pay > Use > Summer Pay Page
	Prior to the Release: The Search field was modified to include historical positions that the employee held in OneUSG Connect. This caused confusion for those submitting Summer Pay and could lead to incorrect payments being processed.
	After this Release: The Search field has been returned to the original criteria and will only return the employee data for the current, active position.
View W-2/-2c Forms	Navigation: Employee Self Service > Payroll Tile > Taxes > View W-2/W-2c
	Prior to the Release: The page seemed confusing to users which resulted in higher-than-average phone calls to the service center.
	After this Release: The message is clearer and the page is more streamlined, which should positively impact user experience.

 Institutions must opt in ot this process by sending a SNOW Ticket titled, "Exception Hours Cleanup – 7.00". The ticket should include the following: An excel file of the Exception query for your institution. A count of the number of rows you want deleted. The thru date you used to extract you Exception file. (Thru date should be (12/31/2024)
The Batch Approve Reported Time process will be updated to only approve hours that are reported within 75 days prior to the current run date. For Hours that need approval beyond 75 days, a request must be submitted to SSC for assistance.
