<p><b>Invalid Funding Report</b></p>	<p><b>OneUSG &gt; Commitment Accounting &gt; Invalid Funding Report</b></p> <p>Enhancements to the Invalid Funding Report will make it more user friendly by providing a CSV output file that does not require additional formatting when the Combo Code field is blank. On a new Run Control ID, PDF format will need to be selected, on the Process Scheduler Request screen, when running the report. A separate CSV file will be created.</p> <p>With this modification, the PayGroup column is now the 4th column on the report. All other columns remain in the same order.</p>
<p><b>BOR_HR_POSN_OVER_ALLOCATED (Over Allocated Positions)</b></p>	<p><b>Manager Self Service &gt; System Manager Reporting file &gt; Commitment Accounting (under Queries/Query Manager section) &gt; Over Allocated Positions</b></p> <p>A link to BOR_HR_POSN_OVER_ALLOCATED has been added to Manager Self Service. This query shows positions where the Actual Head Count is greater than the Maximum Head Count.</p>

<p><b>Additional Info for Promoting/Demoting into Filled Position</b></p>	<p>When managers initiate a request to promote or demote an employee, they should be alerted when the position into which they promote/demote an employee is filled or partially filled.</p> <p>Two columns have been added on the position look up prompt 1 for <b>Employee Counter (current headcount)</b> and another for <b>Max headcount</b> for each position</p>
<p><b>State Charitable Contribution Campaign (SCCP)</b></p>	<p>Additional development has been done to configure institution-specific details into OneUSG Connect. While this will not be readily visible to employees or practitioners at this time, we do want to ensure institutions are aware that there will be a tool in OneUSG Connect to allow employees to select SCCP contributions to be deducted from their paychecks. Additional access and enhancements will be released in the near future.</p>
