<p>Create Benefit Adjustments</p>	<p>An update to the process was made to correct erroneous rounding cents adjustments for those participants subject to 7/5ths deductions.</p> <p>This will not retroactively correct any erroneous adjustments already created, which will need to be corrected using the "Enter Adjustments" process</p>

BCAF RET Accounting Load	<p>An update has been made to this process to show 4 new chartfields in PERS_SERV_BOR and HR_ACCTG_LN tables:</p> <ul style="list-style-type: none"> • Operating Unit • PCBU • Activity ID • Chartfield1 <p>These fields will be displayed in PERS_SERV_BOR and HR_ACCTG_LN tables if exists for institution.</p>
Enter Benefit Adjustments	<p>Practitioners can now attach and review supporting documents for auditing purposes when entering Benefits Adjustments.</p> <p>The process will now require approval by a second practitioner.</p> <p>Adjustments must be in approved status before data will populate in tables for journal generation.</p> <p>There is a new Security Role for approvers: BOR_BEN ADJUSTMENTS_APPROVER</p>

Create Tenure Data	<p>NavBar > Navigator > Workforce Development > Calculate Tenure > Create Tenure Data</p> <p>The SetID is being made a key field to ensure that when a practitioner is entering/updating the tenure data record for a faculty member it pulls only the Rank Tenure Home departments assigned to the institution.</p> <p>This will be obvious and very helpful for those institutions that may share faculty – ensuring that the Tenure Home Department number and description are populated based on the institution entering the data.</p>

<p>Tax Update 20-B</p>	<p>To ensure regulatory compliance we have applied PeopleSoft Tax Update 20B to this release. The update includes:</p> <ul style="list-style-type: none">• Federal and State regulatory compliance updates for taxes and garnishments• Bug fixes required for the new 2020 W4 in Employee Self Service (ESS)• Updates to Paycheck Modeler so new 2020 W4 elements are available. Previously, the new 2020 W4 elements were not included in Paycheck Modeler.• Modification to the 2020 US Federal Form W-4 for Automatic Employee Tax Data functionality. New hires coming into the system in tax year 2020 using SMART HR Template, Add Employment Instance, and Manage Hires incorrectly defaulted to Federal Form W-4 Version “2019 or Earlier”. This modification updates the default to Federal Form W-4 Version to “2020 or Later” on the Federal Tax Data page.• Modification to the 2020 US Federal Form W-4 for employee rehire scenarios. Before this update, rehired employees in



	<p>the same Company and Tax Location incorrectly created a new row of employee tax data with Federal Form W-4 version "2020 or Later" even though another active job instance existed in the system for the rehired employee. Now, employee's rehired in the same Company and Tax Location will not create a new row of tax data if at least one active job instance already existing in the system for the rehired employee.</p> <ul style="list-style-type: none">• New South Carolina Form SC W-4 default Tax Status for South Carolina update to "S" (Single) to comply with the new SC W-4 instead of "N" (Not Applicable) as this value should no longer be used.• 2020 Federal Tax Data allows updates to various fields for Non-Resident Aliens on Admin Page and in Employee Self Service. <p>Academic Year Pay</p>	<p>Due to the COVID-19 protocols, and subsequent Salary Reduction Plans' impact on our HR communities, Academic Year Pay will be piloted by GA Tech, and GA State only for FY 2020-2021.</p>

Non-Standard and Supplemental Pay Matrix	<p>Updates to the Non-Standard and Supplemental Pay Matrix to support Academic Year Pay will include new Rate Codes and Earnings Codes. Be on the lookout for a new MCOP Matrix coming soon.</p>

Personal Details Tile	<p>An employee is now able to make updates to their home address and mailing address while on the same page without getting an error.</p> <p>Previously employees had to exit the page completely after making one update and return to make the second update.</p>
MSS Notification Emails	<p>All MSS notifications have been updated to include:</p> <ul style="list-style-type: none"> • EMPLID • EMPL RCD • Employee Name • Department • Initiator name • Approver name
MSS Adjust Leave Balance Transaction	<p>The approval page on the MSS Adjust Leave Balance transaction has been updated to include both current and new information related to the leave balance adjustment.</p>
MSS Transfer Transaction	<p>Additional action/reason combinations for "Transfer" have been added to accurately</p>



	<p>reflect data changes for employees who begin and end acting or interim positions with (or without) associated pay rate changes.</p> <ul style="list-style-type: none"> • Addition of action "Transfer" and reason code "Begin Interim Position" • Addition of action "Transfer" and reason code "End Interim Position" • Addition of action "Transfer" and reason code "Begin Acting Position" • Addition of action "Transfer" and reason code "End Acting Position"
<p>Approval routing for E paygroup</p>	<p>MSS transactions for E paygroup (Non Exempt Faculty) will now route the same as F (10 Month Faculty) paygroup.</p> <p>Previously, the E paygroup was utilized for Exception Hourly employees and was following the Staff workflow.</p>
